Interested and eligible applicant shall submit the application addressed to the Chairman, Goa State Pollution Control Board, Nr. Pilerne Industrial Estate, Opp. Saligao Seminary, Saligao, Bardez Goa 403511, on or before 18th May, 2021, giving details such as educational qualifications, work experience if any, valid employment exchange card, birth certificate, one passport size photograph affixed to the application, 15 years continuous residence certificate in Goa issued by the Competent Authority, Caste certificate issued by the Dy. Collector and scrutinized by the Scrutiny Committee constituted by the Directorate of Social Welfare, Govt. of Goa, and any other relevant certificates / documents. The application as per the

	proforma along with the documents attached shall be submitted to the office of the Goa State Pollution Control Board.		
2.	Late, incomplete applications and not fulfilling the requirements in any manner are liable to be rejected summarily by the Board.		
3.	Prescribed Educational qualifications mentioned above are minimum and mere possession of the same does not entitle the applicants to be called for the competitive written examination.		
4.	Only eligible candidates fulfilling the criteria as per recruitment rules / advertisement shall apply. However, the candidature of shortlisted shall not be considered, if he / she is found ineligible at the time of verification of essential documents, even though he / she has passed the competitive written examination		
5.	A competitive written examination shall be held for the eligible candidates for short listing and selection.		
6.	The total marks of competitive written examination shall be 100 and duration of competitive written examination shall be two hours.		
7.	Only those candidates scoring 65 marks and above in the competitive written examination shall be called for the oral interview		
8.	The Board shall invite five times the number of candidates as against the number of vacancies advertised for the oral interview purely on merit of the competitive written examination. In case there are more candidates securing the same number of marks as the last candidate, all such candidates shall also be called for the oral interview		
9.	The marks for oral interview are 40. Candidates called for oral interview should obtain a minimum of 50% to be eligible for final selection.		
10	The final selection shall be in the order of merit based on the competitive written examination marks scored and the oral interview.		
11.	The syllabus and scheme of examination shall encompass questions based or essential qualifications, general knowledge, reasoning ability, quantitative aptitude etc. commensurate with the degree / level of understanding required for the post.		
12.	The entire result shall be published on the Notice Board of the Board, as well as on the portal: goaspcb.gov.in and www.goa.gov.in.		
13.	No TA/DA shall be paid for attending the written examination		
14.	The selection of candidates is further subject to the relevant rules in force		
15.	The Board shall draw a waiting list, which shall lapse on declaration of the date of a subsequent examination for the same category or after a period of one year from the date of preparation of such wait list, whichever is earlier.
