- 2) The applicant must be a citizen of India.
- 3) Reservations and Age Relaxations will be followed as per Government of India norms.
- 4) Candidates willing to apply for the advertised post are requested to fill online application form available in the Institute's website <u>www.nitgoa.ac.in</u>
- 5) The applicant must ensure his/her eligibility for the post in respect of Age, Qualification Experience, Specialization, Trade, and other requisite criteria as published in this advertisement and only then should apply.
- 6) Application fee is to be paid while submitting the online application form.
- 7) Candidates are advised to fill the online application form completely and carefully. No appeal will be considered to correct the information given in application form after submission.
- 8) Candidates shall complete the online form in all respects without leaving any column blank. Incomplete applications will be rejected. Please enter "NA" if the information sought is not applicable.

- 10) Candidates should upload the Self-attested copy of certificates and documents as prescribed under Recruitment Rules for the Post, which are listed as below.
 - a. Proof of Date of Birth (If not attached, application will be rejected).
 - b. For SC/ST/OBC (Non-Creamy Layer)/EWS/PwD candidates, the application form should be attached with a copy of the relevant certificate, as per the Government of India norms.

 - g. 10+2 Certificate.
 - h. Final Year Mark sheets / Grade Cards and Diploma /Degree Certificates for the Examinations mentioned in the Application Form in the same sequence. Any degree mentioned will not be considered unless copies of certificates are attached.
 - i. Experience Certificate from employer. Any experience claimed without certificate will not be considered.
- 11) Applications without attaching appropriate certificates/documents shall be rejected.
- 12) Incomplete applications/applications without relevant supporting enclosures/applications not in prescribed form/without application fee (where applicable) will be out-rightly rejected. Interim correspondence will not be entertained or replied to.

- 16) If called for the selection process, applicants will have to bring printed copy of the online application, self-attested photo copy of certificates in support of age, mark sheets and certificates of educational qualification, experience certificate/s, category related certificates (as applicable) and other original documents in support of the information submitted in the online application.
