1. Interested and eligible applicant shall submit the application addressed to the Chairman, Goa State Pollution Control Board, Nr. Pilerne Industrial Estate, Opp. Saligao Seminary, Saligao, Bardez Goa 403511, on or before **06**th **July, 2021**, giving details such as educational qualifications, work experience if any, valid employment exchange card, birth certificate, one passport size photograph affixed to the application, 15 years continuous residence certificate issued by the Competent Authority, Caste certificate issued by the Dy. Collector and scrutinized by the Scrutiny Committee constituted by the Directorate of Social Welfare, Govt. of Goa, and any other relevant certificates / documents. The application as per the

	proforma shall be submitted to the office of the Goa State Pollution Control Board.
2.	Late, incomplete applications and not fulfilling the requirements in any manner are liable to be rejected summarily by the Board.
3.	Prescribed Educational qualifications mentioned above are minimum and mere possession of the same does not entitle the applicants to be called for the written examination. Where the number of applications received is large, the Board shall short list the candidates.
4.	Only eligible candidates fulfilling the criteria as per recruitment rules / advertisement shall apply. The documents shall be attached to the application form at the time of applying for the post. However, the candidature of shortlisted shall not be considered, if he / she is found ineligible at the time of verification of essential documents, even though has passed the examination
5.	Skill test shall be conducted for selection / short listing of the candidates.
6.	Selection of candidates shall be determined in accordance with the marks obtained by each candidate in skill test as per merit. The entire result shall be published on the Notice Board of the Board, as well as on the portal:
-	goaspcb.gov.in and www.goa.gov.in.
7.	If two or more candidates secure equal marks in the skill test, the order of merit shall be as per their date of birth and if in case the date of birth is also the same then the candidates possessing higher educational qualifications will be placed higher in the merit list.
8.	There shall be no allocation of marks for educational qualifications and the selection of candidates shall be done strictly as per the marks scored in written examination/skill test.
9.	Prescribed Educational Qualifications mentioned above are minimum and mere possession of the same does not entitle the applicants to be called for the written examination. Where the number of applications received is large, the Board shall short list the candidates.
10.	No TA/DA shall be paid for attending the skill test / interview
11.	The Board shall draw a waiting list, which shall lapse on declaration of the date of a subsequent examination for the same category or after a period of one year from the date of preparation of such wait list, whichever is earlier.
